- 2. Submission of Subject Selection Form: The filled subject selection form, which was shared with you earlier, must be submitted via email to info@bisk.edu.in. Please ensure timely submission to secure your preferred subjects.
- 3. Available Seats: Birla Public School offers 18 seats each in Science and Humanities streams, and 30 seats in Commerce. These seats will be allocated on a first-come, first-served basis. For inquiries regarding seat availability, kindly contact the front desk at 9251028301 or 9251028311.
- 4. Re-Enrolment Form: Failure to submit the re-enrolment form by the specified deadline will be interpreted as a decision not to re-enroll your ward in Grade XI. Consequently, your ward will be de-enrolled from the school.
- 5. Tuition Fee Discount: Existing Grade X students are eligible for a 10% discount on tuition fees until April 7, 2025. No requests for fee relaxation will be entertained after this date.
- 6. **Payment Timeline:** The deadline for payment of Term-1 fees is April 10, 2025. Please ensure timely payment to avoid any inconvenience.
- 7. The reporting date for Grade-XI is 7th April, 09.00am to 01.00pm. The class will commence from 8th April 2025.

- Science and/or Mathematics can only be opted if the student has scored 70% and above in Grade X Examination (in Mathematics- Standard and Science subjects).
- Optional subject will not be changed once selected. The subject change fees will be Rs. 50,000/-.
- Students who secure more than 60% marks in Grade X (Mathematics, Science, SST) will be considered for Commerce.
- The students who want to enroll in Grade XI shall submit the subject combination along with Grade X marksheet issued by Board (certified by school) to the Admission Committee at the time of applying for admission.
- The Admission Committee will confirm the provisional admission through mail and the Parent has to pay Term-I fee within three days from the date of the receipt of the mail. No guarantee of the admission if fees is not paid within stipulated time.
- No students would be allowed to join school without confirmation of the Admission Committee and all requests received after due date would summarily be rejected.
- New session will commence from 1<sup>st</sup> week of April 2025. The Provisional admission will be given on payment of fees by 10<sup>th</sup> April 2025. If the student attended the classes and applies for TC by 30<sup>th</sup> April 2025, the fees for the quarter will be charged.
