Dear Parents,
Greetings from the school.

As per the CBSE guidelines for the Class X Second Board Examination 2026, students who have appeared in the First Board Examination and meet the eligibility criteria are permitted to appear in the Second Board Examination for improvement of performance in permitted subjects.

The Second Board Examination is optional. If students feel that they did not perform well in the First Board Examination, they may appear in a maximum of three subjects (Science, Mathematics, Social Science, and Languages).

Please note the following:

- No subject change is allowed between the First and Second Board Examinations, except in Mathematics. Students may opt to change from Mathematics Standard (041) to Mathematics Basic (241), if they wish.
- Once submitted, no correction or addition in the List of Candidates (LOC) will be permitted.

Examination Fee Details (as prescribed by CBSE):

1. ₹320 per subject
2. ₹960 for up to three subjects
3. A late fee of ₹2000 will be applicable for submissions made after 28th March 2026.
